The purposes of these presentations are to increase ICTS Steering Committee awareness of leaders and organizations working in the community to provide health-related services to Orange County, discover what potential there is for research projects, student placements, partnerships, and sharing of resources: what the ICTS can offer you, the benefits of research for your organization.

4. Speaker series 2015-2016

Barry Ross, Vice President, Healthy Communities St. Joseph Health, spoke about leveraging research to impact health policy.

Barry was inspired by Tyler Norris (<http://www.tylernorris.com/index.html>) 15 years ago with his message that there will never be enough money for all the programs necessary to optimize population health, so action must target changes in policies.

First half of slide presentation was adapted from a PowerPoint by the Consortium for Health Policy and Systems Analysis in Africa (CHEPSAA) (www.slideshare.net/hpsa_africa).

Important points:

- HPSA research questions are rooted in social structures such as policies and systems, rather than in programs, diagnoses, or a disciplinary base.
- The evidence base is very sparse, even recommendation on the CDC website had little evidence to substantiate their statements.
- Difficult research to conduct because:
 1. It's messy—difficult to design well given the complexity of society
 2. Funding is lacking for this type of research (largely because of #1)
 3. There is no methodological gold standard for policy and systems research like there is in medicine (e.g. randomized clinical trial)

Discussion

1. We're not really able to study this topic effectively given the complexity of the subject of study and limitations of study designs and resources
2. Rather than focusing on the amount of money we spend on healthcare in the US, we should be discussing where we are spending our dollars. More money should go toward research in health policy
3. There is a slow increase in opportunities to research this sort of thing, e.g. via funding from RWJF.

Then Barry presented the work he has done with St. Jude's Healthy Communities initiative.

He presented: Active Living by Design, Community Action Model, national program of the Robert Wood Johnson Foundation, as an inspiring model for Healthy Communities, and the development of Move More Eat Healthy, in conjunction with the Partnership to Improve Community Health, Orange County CDC grant.

Action by these collaborating entities work to change policies that improve health, such as

- Encouraging Orange County cities to adopt/endorse either the HEAL or Let's Move Campaigns
- Encouraging local government to institute land use, transportation, and planning to promote physical activity, nutrition, and reduced obesity.
- Establishing programs in schools that encourage physical activity (e.g. Fit Kit Centers)
- Policies that support exclusive breastfeeding and obesity treatment/prevention

- Rethink Your Drink campaign in schools and offices.

The challenges in demonstrating efficacy relate to lack of outcomes measured, determining what efforts impact what outcomes that are measured, time, and resources.

Ideas for improving outcomes measures for these tactics include:

- Use of CHIS questionnaires to insert one or two targeted questions to meet your needs
- UCI to conduct training in standardizing processes of measuring height and weight of kids being followed
- Ensuring you have a great statistician to conduct multi-level analyses
- Determining your “best estimate” based on other evidence available in the literature
- Match schools within district that do and do not have Fit Kits
- Random sampling of neighborhoods in catchment areas
- Get university students to collect this data
